

#### INTERNATIONAL MASTER & MBA SCHOLARSHIP APPLICATION – OCTOBER 2022 INTAKE

EADA awards scholarships to outstanding candidates who demonstrate the potential for superior performance in the programme. Scholarships are merit-based and cover between 10% and 25% of the programme fee the Scholarship for Excellence covers between 10% and 35% of the fee).

### **Eligibility and conditions**

- Only candidates who have successfully completed the admission process are eligible to apply. We encourage candidates to prepare their scholarship application as early as possible. Please note that the scholarship application deadlines are directly after the admission deadlines. For this reason, many candidates choose to start preparing their scholarship application before actually being admitted.
- To accept a scholarship, candidates are required to enrol in their chosen master's programme within 14 working days of being awarded the scholarship.
- Candidates can apply to a maximum of two EADA scholarships, although they will receive a maximum of one award.
- Scholarships and discounts do not stack; candidates who receive multiple awards will be automatically awarded the scholarship or discount with the highest value.
- Acceptance of the scholarship entails participation in an academic or administrative project proposed by EADA during the academic year.

#### **Deadlines**

There are several scholarship deadlines each year. We encourage you to apply as soon as possible to increase your chances of receiving a scholarship. The required documentation must be received via email (<a href="mailto:scholarships@eada.edu">scholarships@eada.edu</a>) by the corresponding deadline.

After the last deadline, EADA will have a rolling scholarship deadline with any remaining scholarships awarded to outstanding candidates on a first-come, first-served basis.\*

# Results & payment of scholarship

EADA will notify candidates of the results via e-mail within 2 weeks of the corresponding deadline.

EADA scholarships and discounts do not stack; candidates who receive multiple awards will automatically be awarded the scholarship or discount with the highest value. All scholarships will be applied to the final payments of the programme.

## 2. Prepare the following documentation:

- Scholarship Application Coversheet (page 3 of this document)
- Scholarship Awardee Contract (page 4 of this document)
- A letter introducing yourself and explaining why you are an outstanding candidate for the scholarship. This letter must be written in the language of the chosen programme.
- A letter of recommendation from your professional or academic background. This recommendation must be written by someone other than the two references used during the admission process.
- A list of other activities that you are involved in such as student associations, professional forums, sports, etc. (when applicable)
- Additional documentation for the Scholarship for Excellence only: A GMAT score of 700
  or higher or documents demonstrating academic/professional excellence.
- Additional documentation for the Future Entrepreneurs Scholarship only: A 350-500 word description of the entrepreneurship project that you hope to launch after graduation.

### SCHOLARSHIP AWARDEE CONTRACT

All scholarship candidates must sign this document describing the rights and duties of scholarship awardees. Signing this document means that you agree to these conditions in the case that you are awarded a scholarship.

- Scholarship recipients are required to perform well in the programme, and to perform assigned duties at a high standard.
- Scholarship recipients carry out an academic or administrative project while at EADA. This project may be assigned at any time during the academic year to which the scholarship has been applied. Projects will not be selected assigned before the programme begins.
- Candidates submit a detailed description of their previous experience and profile, which will be used to assign projects. This summary will be requested later via email.
- Scholarship recipients have the right to receive the full amount of the corresponding scholarship awarded in the form of a discount applied to the total programme fee. All scholarships will be applied to the final pending payment(s) of the programme.
- EADA scholarships and discounts do not stack; candidates who receive multiple awards will be automatically awarded the scholarship or discount with the highest value.
- To accept a scholarship, candidates are required to enrol in their chosen master's programme within 14 working days of being awarded the scholarship.

### **Non-Disclosure Agreement**

The scholarship awardee will exert reasonable efforts to maintain disclosure of all the information contained in this document, including but not limited to, the amount of the scholarship and the project assigned, in confidence, except in certain cases in which EADA Business School permits disclosure of the project details to faculty, alumni, associated companies or current students.
